Other work is more visible such as managing public art projects or presenting annual awards for excellence. Current and recent work includes: encouraging life-long creative learning programs including the following programs: Arts & Cultural Education Integration for Student Excellence and the Creative Convergence conference. TAA promotes creative sector programs and collaborative initiatives. Including a membership program, an Annual Arts &

Region 9 Regranting: The Arts Alliance has been an administrator for the Michigan Council for Arts and Cultural Affairs (MCACA) regranting program since 2008 and currently serves in that capacity for six Michigan counties in Region 9: Hillsdal, Jackson, Lenawee, Livingston, Monroe and Washtenaw. The Arts Alliance holds training sessions and offers grant-seekers an excellent set of training materials including: an overview of the guidelines, a sample narrative, model budget and a tutorial on using the EGrant system. Applicants needing additional guidance are offered personalized assistance via telephone, email and one-on-one meetings. Peer review panels are convened to evaluate, score and distribute minigrants.

2015 Public Art & Design Plans - The Arts Alliance (TAA) is managing a number of public art and design projects including: 1) PowerArt! in partnership with the Ann Arbor Downtown Development Authority, the Ann Arbor Public Art Commission (AAPAC), this project to wrap 42 traffic signal boxes in downtown Ann Arbor with vinyl-printed replicas of local artists' work. 2) Canoe Imagine Art. Four commissioned artist teams vetted by a jury and then a public vote each received a \$5,000 stipend for creating sculptures from retired canoes that now live in Ann Arbor city parks along the Huron River, funded in part by the MCACA, the City of Ann Arbor and was a partnership with the AAPAC and Parks and Recreation Department. 3) After almost a dozen community sessions, TAA released the Re-Imagine Washtenaw
