Region 9 Regranting: The Arts Alliance has administered the minigrant program for the Michigan Council for Arts and Cultural Affairs (MCACA) program for Livingston, Monroe and Washtenaw Counties since 2008 and was asked by MCACA in 2014 to add Jackson, Hillsdale and Lenawee counties. The Arts Alliance holds training sessions and has an excellent set of training materials to offer grant-seeker including: an overview of the guidelines, a sample narrative, model budget and a tutorial on using the EGrant system. Applicants needing additional guidance are offered personalized assistance via telephone, email and one-on-one meetings. Peer review panels are convened to evaluate, score and distribute minigrants.
