As the champion for Washtenaw County's Arts & Creative Industries, The Arts Alliance provides services and gives voice to the importance of the sector's impact on quality of life in the region. Its multi-faceted communication channels promote the creative sector's programs and collaborative initiatives while working to build appreciation, value and investment. General services include a membership program, an Annual Arts & Creative Industries Guide, a biweekly online eNewsletter and the Cultural Leaders Forum.

4b (Code:) (Expenses \$ 97,376 including grants of\$ 39,520) (Revenue \$)

The Arts Alliance facilitates projects for the arts and creative sector while educating the public on the benefits of supporting creative endeavors. Current projects include serving as administrator for the Michigan Council for Arts and Cultural Affairs regranting program; conducting a multi-phased assessment of the need for, feasibility of, economic impact potential and business model possibilities for one or more sustainable multi-purposed spaces for artists and creative individuals; and managing PowerArt! a multiyear project to wrap 42 traffic signal boxes in downtown Ann Arbor with vinyl-printed replicas of local artists' work to power public access to the arts through street-level community involvement.

Arts & Creative Education Integration for Student Excellence - The Arts Alliance is partnering with the Washtenaw Intermediate School District to ensure that all 47,000 students attending preK-12 schools in Washtenaw County have equitable access to creative education. The ultimate objective is a long-term sustainable plan to offer students the chance to benefit from high-quality, consistent, sequential and standards-based education through arts, culture, design and creativity. The project was recently awarded a highly competitive a grant of \$100,000 from the National Endowment for the Arts.
